## **Waterfront Guidelines**

- Persons making use of the jetties and slipway do so at own risk.
- No objects bottles, papers, plastic, liquid or any other foreign matter may be deposited in the river.
- No diving whatsoever into the river from the jetties is permitted as this could be extremely dangerous.
- No camping and tents are allowed at the fishing area.
- No fires in the fishing area, except in the designated areas.
- Any Tenants/Owners that do not own or rent a boathouse on the Estate are not allowed to launch from the Estate.

## List of Fines

- Speeding/reckless driving – R500
- Skipping stop signs – R500
- Driving without a licence – R500
- Driving with golf carts in the Estate without any lights or reflectors after sunset R500
- Creating a public nuisance – R1000 to R3000
- Unauthorised use of access cards by any persons – R500
- Unauthorised entry – R500
- Treating Security personnel in an abusive manner – R1000 to R3000
- Residents bring any form of labour into the estate without following the correct procedures in terms of permits – R2000 pp
- Residents allowing anybody into the Estate without following correct procedures – R2000 pp
